


A Closer Look





BEFORE FIRST USE

ARIA is cordless and rechargeable. Before use, charge fully for 12 hours. ARIA can run up to 60 minutes on a single charge.

CHARGING

To recharge, insert the included USB Cord into the port on the side of the ARIA. Then connect the USB end of the charging cord to a USB port of a computer or a USB wall adapter and then plug into an electrical outlet. When the battery needs charging, the Power Indicator light will turn red. If the device is fully discharged the device will power off. As the battery charges, the red light will turn to green when the device is fully charged. Recharge the ARIA only as needed and up to 12 hours only. DO NOT overcharge which can shorten the battery life. Disconnect the Charging Cord when not charging the device. ARIA should be powered OFF while charging. Do not charge ARIA for more than 24 hours.



FILTERS

Use a new filter for each treatment. Remove treatment tip and plastic cap insert foam filter. Sealing plastic rings are also replaceable. Remove filter after use with tweezers and discard



When adding toner to your ARIA, please make sure it does NOT contain any oil based ingredients as they are too thick to micronize and will cause the mister to malfunction.

Once you have assured of the full charge of your ARIA device you can proceed with your treatment.

MICRODERMABRASION:

ARIA provides professional-grade exfoliation treatment to remove dulling dead skin and uneven texture.

- 1. Wash your face and neck then pat dry.
- 2. Attach Microdermabrasion Treatment Tip. The NanoMist function can be used during your microdermabrasion treatment by pressing the mist button.
- 3. While using your ARIA use short, even strokes, holding skin taut with free hand, then move the tip across your skin in 1 to 2 inch size areas.
- 4. Begin by slowly performing passes over treatment area, gradually increasing ARIA speed as needed. Always start in low speed and never keep in one place for too long.









Test a small area first on forearm in a way that you feel suction. Move in a straight line and wait one hour to evaluate results

Usage Guide

PORE EXTRACTION:

ARIA provides professional-grade pore extraction to help remove sebum, reduce pore size, and purify skin.

- 1. Wash your face and neck then pat dry.
- Attach your preferred Pore Extraction Treatment Tip.
 The NanoMist function can be used during your pore extraction treatment by pressing the mist button.
- While using your ARIA use short, even strokes, holding skin taut with free hand, then move the tip across your skin in 1 to 2- inch size areas.
- Begin by slowly performing passes over treatment area, gradually increasing ARIA speed as needed. Always start in low speed and never keep in one place for too long.

REHYDRATE WITH NANO-MISTER:

ARIA's NanoMister transforms toner or purified water to infuse into detoxified pores with calming and soothing hydration.

Expert Advice

QUICK TIPS TO OPTIMIZE YOUR RESULTS WITH ARIA:

- 1. Licensed Aestheticians
 recommend performing
 diamond microdermabrasion
 in short, upward and outward
 movements. Treatment Areas
 should be 1"-2" long. Avoid
 areas of thin skin when using
 the Microdermabrasion Tip like
 around the eye area and lips.
 ARIA's Microdermabrasion Tip is
 ideal for use 1 time weekly.
- 2. After the first Vertical pass with the Microdermabrasion Tip, you may decide to make a second pass in the opposite direction.

 Aestheticians refer to this as cross hatching. It is best to make only one pass as your skin is getting used to microdermabrasion.
- 3. ARIA operates optimally when in motion and holding skin taut. It is important to KEEP ARIA MOVING during use. Never keep ARIA stationary over one area of skin. Moving in short 1-2-inch sections is recommended and always hold skin taut with opposite hand.
